EXECUTIVE DIRECTORS REPORT -

- Barsh and Kate Cote are attending an HR conference in Bismarck 4/17-18
- Masterplan last meeting to finalize the final draft is scheduled for 4/23. Interstate will plan to present draft at next month's board meeting.

- Grants- we are waiting to hear about the heritage Grant.
- Garrison grant \$27,000 to update the frisbee golf and bathrooms at Spring Lake Park.
- CAPRA, everything has been submitted for the assessment. We are getting ready for the site visit.
- Davidson Park project is ongoing.
- Water world project is ongoing and on time.

HR- No changes in staff. Working on CAPRA to get the submission in.

Special Events- Puzzle palooza will not break for the summer and will be every Tuesday now through December Nerf wars is coming up and is filling up fast. Mother Daughter Day is coming in May. Kids Camp will be opening soon for signups. Roller Skate will go through the summer.

Campus Club- we have guests kids here to showcase their boardgame that they invented. There was a competition between all 6 schools and the winners are here to present the game. The winning game was Halsey from McVay. They presented the game to the park board.

Marketing- Social media outlets were up. The website traffic is up with 60,000 hits this month. The brochure for June-Dec is out. We went to job fair at the high school.

Child Sitting- Has been steady with very busy and slow days adding to a little less than last month.

Parks-Working on clearing snow. Now moving to fields and getting them ready for spring sports. HVAC motor maintenance is ongoing. Fixed water features in the leisure pool and working on the hot tub. Patching spots in parking lots. Then lines will be added at the golf course. All the fields are almost ready. Batting cages are open and waiting on turf for the new one. Golf course opened on the 13th. Lights were fixed and trees were trimmed, all maintenance was done on the golf carts. Raymond center has been getting improvements including paint, lighting, and flooring. Raymond courts are busy with soccer and volleyball.

Facilities- Getting through the busiest months of the year. Working with turf space and trying to let all teams utilize it. We have had 4 track meets and one with over 700 kids here everything was a success. Next year Stanley is having their big meet here instead of Minot. Rodeo is coming April 18-20. Next year there will be an increase in fees for the Raymond center. Fall reservations have begun early 2025. There is a need for turf space, and it is being managed to try to get all teams on it and use it.

Maintenance- Starting to work on spring cleaning. Making plans to get roof top units cleaned. They had a robot scrubber cleaner demo and hoping it is something we will get in 2025. Making progress with the overnight cleaning crew.

Guest Services- March was busy with lots of teams and programs. Adult memberships are up. 26,000 est. people came through the facility in March.

Aquatics- There was an Easter Egg hunt, and it was well attended. Swim lessons are full with 56 kids. 50-meter-long course will be starting soon. Lifeguards will be certified to give CPR.

Recreation- There are lots of spring programs running. Trael sports are full and busy. Baseball tryouts were held. There were good numbers of boys for teams. We offered a new LaCross clinic with 30 people attending. The second annual pickle ball tournament was held with 50 teams. Ballin in the basin had 90 teams. All summer programs opened. 5 outsourced summer camps have been offered.

Fitness- Group fitness numbers are steady. Personal training was at its highest with \$10,300 in sales.

- a. WPRD 2023 Audit
 - a. Audit is completed and it went very well. Every 3 years they have to go to the national level. Financial feedback was that we had a good year last year. We have been heavily involved in grants and capitol projects. Making sure that all receipts or projects are tracked to make the process faster in the future. The bond council got the report. The report is uploaded and accessible to the public.
- b. JB Brothers Harmon Park Quote
 - a. Resurfacing quote to turn the Harmon Parks courts into a permanent pickle ball court. They need to be resurfaced with asphalt and then cure for a month before the surfacing of the actual court. We will have 6 courts. MOTION by Owens, SECONDED by Jangula, We approve the motion to move forward with resurfacing quote ROLL CALL AYE: Liffrig, Owens, Jangula, Heller, Roness. NAY: None. ABSENT: None.
- c. Norby Golf- Grading Plan- Tabled until next month.
 - a. Would like to make the contract for the 2025 budget. Approving this now will kickstart the project and get him here to look over the course now to get the work done. This would just be engineering. He can look where the holes and grading will be placed.
- d. WPRD Vehicle Fleet Proposal
 - a. Red Rock turned in their proposal, we put out an RFQ to all local dealerships. Our fleet now is in bad shape and most of the cars are not safe or broken. The goal here is to restart our fleet, they will be better regulated and have WPRD decals. We would go from 16 vehicles to 10. They will be for staff and must be checked out and regulated. MOTION by Owens, SECONDED by Jangula, We approve the motion to move forward with the new fleet of vehicles as presented in the Quote from Red Rock Ford to include a \$5k program sponsorship. 

Williston Parks & Recreation District/Williston Seas Lions E.J. Hagan M.D. Natatorium Use Agreement

This agreement will cover June 1, 2024, through May 31, 2025. The Williston Seas Lions (Sea Lions) will pay the Williston Parks and Recreation District (WPRD) a sum of \$18,035 for the use of the E.J. Hagan M.D. Natatorium (Natatorium) and the facilities located at the Williston Area Recreation Center as described in the agreement below. Yearly payment will be made in two installments of \$9,017.50 due on June 1st and December 1st. This agreement will be re-evaluated on a yearly basis with the ability to renew upon agreement of both parties.

The priority for space will be WPRD programs, WSC programs, WPSD#007 Programs, Sea Lions, and other user groups. In conjunction with this usage priority ranking, the WPRD facilities, aquatics, and recreation staff will work with each group to utilize the Natatorium to offer the best possible scheduling for all involved.

WPRD will:

- Provide Natatorium for swim practices and meets
- Provide Instruction pool for athletes to warm up and cool down during meets.
- Provide timing system equipment (internal Bulkhead Wiring)
- Provide lane ropes and backstroke flags.
- Provide a limited amount of storage space as available
- Provide a meet managers room (for meets only)
- Provide daily changing room space in the bathroom, under stadium seating (not permanent)
- Provide ticket takers, through the guest services desk, for all meets.
- Move the bulkheads as necessary- non WPRD staff are not allowed to operate the bulkheads.
- Provide space for dryland training if available.

Sea Lions will:

- Have a coach present 30 minutes prior to practice in order for the doors to be unlocked. If a coach is not here, the athletes are not allowed on deck, only in the stands.
- Provide all individualized training equipment including, but not limited to kick boards, pull buoys, snorkels, and flippers.
- Provide at least one coach on deck whenever a sea lion athlete is in the water.
- Provide lifeguard(s) for practices or a coach(es) that is certified lifeguard trained and/or registered with USA Swimming and completed CPR and Safety Training for Swim Coaches. Adequate staffing to ensure the safety of the children during practices and meets.
- Provide all meet management personnel including but not limited to timers, starters, and judges.
- Guarantee that only coaches and board members will go into the equipment storage area.
- Provide the scoreboard and all necessary equipment to run the scoreboard (Touchpads, Plungers, Cables, Horn Start, Wireless Mic for horn start, Laptops, Timing System Software)
- *Any permanent equipment or fixtures are assumed to be WPRD property.

Operations:

- Each season, the Sea Lions coaches will supply team rosters and a list of coaches/Board Members to WPRD for practices/games. WPRD will use the rosters to create and print ARC passes for every rostered athlete/coach/Board Member for the duration of the swim season. All participants must scan their passes at the front desk of the ARC prior to entering their designated practice space unless instructed otherwise by WPRD staff.
- The Sealions will be allowed to conduct dry-land practices at the WPRD facilities under the premises of this contract, provided that the practices are supervised, scheduled, and reserved.
- WPRD and Sealions will work together to develop a procedure that will allow rostered athletes/coaches/Board Members to scan into the ARC. Free entry does not apply to unsupervised or unscheduled practices or for singular entry.
- *Parents are allowed to watch practices but must pay a daily fee or have a membership if using other parts of the WARC.
- Sea Lions and WPRD Staff will do an annual walkthrough of the facility. This would be completed in May of each contract year.

Events:

- WPRD will charge additional fees for special events/meets, except for parent meetings, as determined by the Sea Lions President and WPRD Facilities Director. \$2.00 per athlete per meet will be paid per event (to be paid within 30 days.)
- Special Events will be arranged with the Aquatics Manager. A \$20 per lifeguard fee will be applied per hour.

Liability / Insurance/ Indemnification

Each party is responsible for its own acts and agrees to assume its own liability for those acts and consequences. The liability of Park District is governed by North Dakota Century Code chapter 32-12.1. Park District shall procure and maintain liability insurance covering all the Park District Facilities and Park District's management and operation of the Park District Facilities and adopt and enforce reasonable rules regarding liability insurance for users. Park District shall cooperate with Williston Sea Lions and ensure that Park District obtains property and casualty coverage as provided by state law for the Center's property. Williston Sea Lions will insure its own contents and participants. Except to the extent arising out of negligent acts or omissions, intentional misconduct, or illegal acts of the WPRD, its successors, assigns, and/or anyone for whom the WPRD is legally responsible, the Sea Lions shall defend, protect, indemnify, and hold harmless the WPRD from and against any and all judgments, fines, claims, actions, causes of action, penalties, costs, damages, injuries, expenses, or other liability of any kind to the extent arising from, out of, or as a result of the Sea Lions use of the Natatorium, including but not limited to, the negligent, intentional, willful, or wanton exercise for the rights and privileges herein granted. To the extent permitted by applicable insurance, each party waives any right of subrogation against the other with respect to any bodily injury or property damage occurring on or arising out of the use of the facilities.



THE CASE FOR COMPLEX COMPLETION AND FACILITY UPGRADES

The centerpiece for the campaign is converting the entire playing surface of both diamonds to synthetic turf. Spring seasons for baseball and softball in North Dakota often lead to shortened windows for practices and games. Each year brings numerous instances when both the Tetons and Williston High School lose a number of home games. Synthetic turf would allow more practices and games to be held in Williston for the college, the high school, and surrounding communities

Interesting Fact:

Williston is one of only 2 large cities in ND that do not have turf baseball and softball fields.

In addition to the turf, the complex will receive upgrades to secure the complex with exterior fencing, offer better seating with new grandstands on both fields, and establish restrooms and concessions serving areas to enhance the player and fan experience. Field lighting is also planned to lengthen the amount of time in each day the fields will be playable, especially important during the spring seasons.

LANDMARK NAMING OPPORTUNITIES

Multiple naming and sponsorship opportunities will exist in the newly upgraded athletic complex. Below is a listing of some of the opportunities with examples of similar signage options. Final signage design will continue as the complex progresses.



Athletic Complex Naming

The Athletic Complex Naming is the largest impact naming opportunity as the complex is highly visible on the campus and in the community due to its location at the busy intersection of University Avenue and 18th Street East. Complex naming signage will be the largest of any signage and will be located around the outside of the complex and inside the complex at multiple locations.

Teton Victory Stampede

The Victory Stampede is an exciting feature for the complex. The Stampede will be elevated on a pedestal platform and located between the two fields. The design is to light up when the Tetons score a run. It will be highly visible even when the complex is not being used and will be a head-turning attraction for the complex.



Plaza Naming

The Plaza will be located just inside the main entry gate and will be a gathering place for fans before, during, in-between, and following games. It is planned to house a donor recognition wall as well as the Legends Wall and parts of the Teton Trail. Seating is also planned for spectators who are enjoying food from the concessions stand.

Grandstand Naming

Each field is planned to receive a new grandstand that will contain stadium-style seating for an improved viewing experience. Seating for 150 fans is anticipated. Naming and signage will be located so that any traffic in and out of the complex will see it clearly.





Teton Trail Naming

The Teton Trail will be the pathways and sidewalks that connect the spaces of the complex for those in attendance. It is planned to also educate visitors to the history that surrounds our immediate area with learning stations that highlight the Lewis and Clark Expedition and historic landmarks along the Missouri River. Naming would be visible at every educational station.

Teton Stampede-Single Donor

Four named Teton Stampedes are planned to be located on the grounds around the complex. Each Teton Stampede will be a large, eye-catching display that celebrates the Teton mascot and athletic logo and will incorporate a bit of art to the complex and campus. Signage will located at each of the Stampedes recognizing the donor.





Press Box Naming on Leininger Field

The Press Box will be located amongst the grandstand on Leininger Field, home of the community's fastpitch softball. Signage will be highly visible to passers-by and for fans and visitors inside the complex.

Mini Park Naming

A small park-type area is designed for fans with young kids who may get restless watching the action. It will be located between the two fields and adjacent to the Plaza so those in charge can keep a good eye on their activity.





Fan Zone Naming

Four Fan Zones are planned to allow those fans who may want to bring a lawn chair and watch the games from an area other than behind the plate of each field. Initial design is thought to be similar to a single-level deck with open area for fans to relax and enjoy the games.

Legends Wall Naming

The Legends Wall will highlight a history of baseball and softball in our community, including the successes of our area teams and individual players.





Heritage Butte Naming

Each field will house a display that highlights the history of Teton Baseball and Softball. Significant moments, games, contributors, teams, and players of both programs will be celebrated in written and pictured form.

Building the Herd Stampede

The Stampede theme will also be available for those donors who want to contribute to building a stampede by donating one or multiple buffalo of the larger stampede. Each buffalo will recognize the donor who made the stampede possible.
